COMMENTS FROM CHARITY RETAIL

- After two positive months, total LFL sales fell back in December, falling by -1.2%.
- After a positive run since April, total LFL sales of new goods ran out of steam in December and fell by -3.8%.
- Total LFL sales of donated goods fell by -1.1%, compared to +2.6% seen this time last year.

KEY FACTORS AFFECTING THE MONTH

- A number of charity retailers pointed to lower footfall as a challenge this month the High Street saw flat footfall during December, averaging just +0.9%.
- The weather was cited as another major challenge. The Met Office said December was marked by a series of unsettled weather patterns across the UK. The month began with a mix of rain and wintry showers, particularly affecting northern and western regions.

COMMENTS FROM COMMERCIAL RETAIL

- Total LFL sales of -1.2% recorded by charity retailers underperformed the commercial high street which saw in-store sales grow by a healthy +4.3% in December.
- Commercial high street in-store lifestyle LFL sales grew by +7.5% in December, in-store fashion sales improved by +1.5%, and in-store homeware increased by +3.6%.
- On the 23 December, revised figures from the ONS revealed the UK economy flatlined between July and September, growing by just +0.1%, and is on track to have stagnated over the entire second half of 2024.
